PRELIMINARY NOTIFICATION

Whereas it appears to the District Collector Guntur that the lands specified in the schedule below are needed for a public purpose, to wit, for **“Flood Mitigation Works as part of Amaravati Capital City Project”**, notice to that effect is hereby given to all to whom it may concern in accordance with the provisions of Section-11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act No.30 of 2013).

The Government of Andhra Pradesh has exempted the Social Impact Assessment (SIA) for the Amaravati Capital City Project through Memo No. REV01-LANAOLAND/370/2025-LANDS-V, dated 06-11-2025.

The Joint Collector is appointed as Project Administrator vide notification issued in G.O. Ms. No.1 Revenue (LA) Dept. Dated 02-01-2015 u/s 43(1) of the Act for the purpose of Rehabilitation and Resettlement of the affected families / Displaced families.

By virtue of the powers conferred under Section 12 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, the District Collector, Guntur District, hereby authorizes the Deputy Collector and Land Acquisition Officer, CRDA Land Acquisition Unit, Collectorate, Guntur, along with the staff working under them, to exercise and perform the functions of the Collector.

Further, as per the provisions contained under Section 11(4) of the said Act, it is hereby notified that no person shall make any transaction in respect of the said lands, such as sale, purchase, mortgage or raising of loans, from the date of publication of this notice, without obtaining prior permission of the District Collector.

Objections to the acquisition, if any, may be filed by the person(s) interested within 60 days from the date of publication of this notification as provided under Section-15 of the Act, in respect of area, suitability of land and justification offered for the public purpose before the Land Acquisition Officer and Deputy Collector, CRDA LA Unit, Collectorate, Guntur.
