ORDER:

In the GO 1st read above, the Government have issued the Andhra Pradesh Regulation and Penalization of Buildings Constructed Unauthorizedly and in Deviation of the Sanctioned Plan Rules, 2015 and the application for Regulation and Penalization of Buildings constructed unauthorizedly shall be made through online only.

2. In order to bring transparency and to facilitate easy monitoring of entire process of online Building Penalization Scheme, the Government have nominated Axis Bank for credit card payments as Gateway for payment of online penal charges under Building Penalization Scheme (BPS) and also appointed M/s.Ctrl-S Datacentres Ltd., Hyderabad to host Web Application in their data centre with 64 GB RAM and 2TB storage @ Rs.1.12 lakh (Rupees one lakh and twelve thousand only) per month vide G.O. 5th read above.

3. In the letter 6th read above, the Director of Town & Country Planning, A.P., Guntur has stated that the M/S AP. Online Limited, Hyderabad has submitted invoice for Rs.56,07,638/- towards software design, development, implementation, training and maintenance of On-line Building Penalization Scheme in Urban Local Bodies for the period from 1.8.2015 to 31.10.2015. Further, the M/s.Ctrl-S Datacentres Ltd., Hyderabad has issued invoices for the balance of Rs.19,66,180/- (Rs.2075940 – Rs.109760 = Rs.19,66,180/-) towards cost of private cloud service, Domain etc. up to November, 2015.

4. Further, the Director of Town & Country Planning, A.P., Guntur has stated that the Government have issued orders to the Managing Director, APUFIDC Ltd. Hyderabad to take immediate necessary steps for payment to the Director of Town and Country Planning, AP., Guntur, so as to avoid further delay and DTCP in-turn will reimburse the amount by pooling from all the Urban Local Bodies proportionately. Accordingly, the invoices submitted by the AP online Ltd., and M/s.Ctrl-S Datacentres Ltd., Hyderabad were forwarded to the Managing Director, APUFIDC Ltd., Hyderabad to make payments to the above Consultants as per orders issued in G.O.Ms.No.88, MA&UD (M1) Department, dated: 18.04.2015 and G.O.Ms.No.237, MA&UD (H2) Department, dated:27.10.2015. But, the Managing Director, APUFIDC Ltd. Hyderabad has not made any payment due to non-availability of funds with them. He also informed that the M/s.Ctrl-S Datacentres Ltd., Hyderabad has informed that, if the payments are not made on or before 10th of February, 2016, they have decided to block the Data services for the B.P.S.

Scheme and Director of Town & Country Planning, AP., Guntur has therefore, requested the Government to advice the Axis Bank, Begumpet, Hyderabad to pay the said amounts to the consultants from the Building Penalization Scheme funds available with them under non-operative account in the name of the Director of Town & Country Planning, AP., Guntur.

5. Government, after careful examination of the matter hereby authorize the Director of Town & Country Planning, AP., Guntur to draw and disburse the amounts of Rs.56,07,638/- and Rs.19,66,180/- to M/s. A.P. Online Limited for the period from 01-08-2015 to 31-10-2015 towards Software, development, implementation, training and maintenance of online BPS in ULBs, UDAs and CRDA and M/s. Ctrl-S Datacenters Limited, Hyderabad for the period from 01-06-2015 to 30-06-2015 towards cost of private cloud service, Domain etc. respectively, from the Building Penalization Funds available with the Axis Bank, Begumpet, Hyderabad.

6. The Director of Town & Country Planning, AP., Guntur shall take necessary action accordingly, and furnish compliance report to the Government .
