ORDER:-

In the reference 1st read above, the Finance (Budget-I) Department have allocated an amount of Rs. 89,33,00,000/- (Rupees Eighty Nine Crore Thirty Three Lakh only) in the Vote on Account Budget 2021-22 under the Head of Account HOA: 2217 Urban Development - 01 State Capital Development - 191 Assistance to Local Bodies, Corporations, Urban Development Authorities, Town Improvement Boards etc. - 11 State Development Schemes - (28) Assistance to APCRDA - 310 Grants-in-Aid -312 Other Grants-in-Aid to incur expenditure of payments of quarterly Interest + Principle to the HUDCO, quarterly Interest to the Amaravati Bonds and monthly interest payment to the Consortium of 3 Banks.

2 In the reference 2nd read above, the Metropolitan Commissioner, AMRDA, has requested to accord administrative sanction and release an amount of Rs.89,33,00,000/-(Rupees Eighty Nine Crore Thirty Three Lakh only) the total projected provision in the Vote on Account Budget 2021 under the Head of Account HOA: 2217 Urban Development - 01 State Capital Development - 191 Assistance to Local Bodies, Corporations, Urban Development Authorities, Town Improvement Boards etc. - 11 State Development Schemes - (28) Assistance to APCRDA - 310 Grants-in-Aid - 312 Other Grants-in-Aid so as to enable to make promptly payments of quarterly Interest + Principle to the HUDCO, quarterly Interest to the Amaravati Bonds and monthly interest payment to the Consortium of 3 Banks.

3 After careful examination of the proposal, Government hereby accord administrative sanction and release an amount of Rs.89,33,00,000/- (Rupees Eighty nine crores thirty three lakhs only) from the B.E - 2021-22 (Vote on Account) under the Head of Account mentioned at para 2 above to incur the expenditure of payment of quarterly Interest + Principle to the HUDCO, quarterly Interest to the Amravati Bonds and monthly interest payment to the Consortium of 3 Banks and also to adjust the amount to the PD Account of APCRDA.
