ORDER:

In the reference 3rd cited, Government have accorded administrative sanction and release an amount of Rs.89,33,00,000/- (Rupees Eighty nine crores thirty three lakhs only) from the B.E - 2021-22 (Vote on Account) under the Head of Account HOA:2217 Urban Development – 01 State Capital Development - 191 Assistance to Local Bodies, Corporations, Urban Development Authorities, Town Improvement Boards etc. – 11 State Development Schemes - (28) Assistance to APCRDA - 310 Grants-in-Aid - 312 Other Grants-in-Aid so as to enable to make promptly payments of quarterly Interest + Principle to the HUDCO, quarterly Interest to the Amaravati Bonds and monthly interest payment to the Consortium of 3 Banks.

2. In the reference 4th read above, Government in Finance Department has issued CBRO for the F.Y 2021-22 for an amount of Rs.132,77,00,000/- per each quarter for the total BE Rs.531,08,00,000/- under the Head of Account: 2217 Urban Development – 01 State Capital Development – 191 Assistance to Local Bodies, Corporations, Urban Development Authorities, Town Improvement Boards etc - 11 State Development Schemes - (28) Assistance to APCRDA - 310 Grants-in-Aid - 312 Other Grants-in-Aid; and instructed to ensure that the distribution of budget among the SCO-DDOs under the control of the Department and the HoD Office, duly allocating the amount for the Four Quarters. Government have apportioned the provision among four quarters @ of Rs.132,77,00,000/- for the each quarter (i.e. 1st quarter Rs.132,77,00,000/-, 2nd quarter Rs.132,77,00,000/-, 3rd quarter Rs.132,77,00,000/- and 4th quarter Rs.132,77,00,000/-).

3. In the reference 5th read above, the Metropolitan Commissioner, Amaravati Metropolitan Region Development Authority has requested to issue BRO and administrative sanction and release budget for the remaining 1st quarter and 2nd quarter budget i.e. an amount of Rs.176,21,00,000/- (Rupees One hundred and seventy six crores twenty one lakhs only) (Remaining 1st quarter Rs.43,44,00,000/- + 2nd quarter Rs.132,77,00,000/- Total Rs.176,21,00,000/-) under the Head of Account HOA:2217 Urban Development – 01 State Capital Development – 191 Assistance to Local Bodies, Corporations, Urban Development Authorities, Town Improvement Boards etc. - 11 State Development Schemes - (28) Assistance to APCRDA – 310 Grants-in-Aid – 312 Other Grants-in-Aid so as to enable APCRDA to make promptly payments of the monthly interest and Quarterly Interest to the lending agencies. Further he has also requested the Government to authorize the Assistant Secretary, MA&UD Department as DDO, to draw and credit the amount to the P.D. A/c of APCRDA.

4. After careful examination, Government hereby accord administrative sanction and release an amount of Rs.176,21,00,000/- (Rupees One hundred and seventy six crores twenty one lakhs only) (i.e. Remaining 1st quarter Rs.43,44,00,000/- + 2nd quarter Rs.132,77,00,000/- Total Rs.176,21,00,000/-) under the Head of Account 2217 Urban Development - 01 State Capital Development - 191 Assistance to Local Bodies, Corporations, Urban Development Authorities, Town Improvement Boards etc. - 11 State Development Schemes - (28) Assistance to APCRDA - 310 Grants-in-Aid - 312 Other Grants-in-Aid to incur expenditure for payment of quarterly Interest + Principle to the HUDCO, quarterly Interest to the Amravati Bonds and monthly interest payment to the Consortium of 3 Banks and also adjust the amount to the PD Account of APCRDA.

5. The Assistant secretary to Government (DDO), Municipal Administration & Urban Development Department, Andhra Pradesh, Velagapudi shall draw the amount sanctioned at para (4) above and credit to the P.D A/c of APCRDA (Major Head:8443 - Civil Deposits -00 - M.H.106 Personal Deposits - 02- Grants-in-aid - SH-04 Urban Development Agencies - 002 APCRDA -001 Grants-in-Aid Deposits (Commissioner of APCRDA)) .

6. The Metropolitan Commissioner, AMRDA shall take necessary action in the matter accordingly.
