<u>ORDER</u>:

Government have enacted the Andhra Pradesh Capital Region Development Authority Act, 2014 (Act. 11 of 2014) for establishment of the Capital for the State. Under the provisions of the Act an area of about 7068 Sq.KMs are notified for Capital Region, and 122 Sq. KMs as Andhra Pradesh Capital City Area vide G.O.Ms.No.253, Municipal Administration & Urban Development (M2) Department, dt.30.12.2014. Chapter IX of the Act, 11 of 2014 provides for Voluntary Land Pooling Scheme for the purpose of Development of the Capital. Government have issued orders vide G.O.Ms.No.257, Municipal Administration & Urban Development (M2) Department, dated 30.12.2014 giving effect to the said Land Pooling Scheme as stipulated in the Chapter IX of the Act 11 of 2014 . The Land Pooling Scheme has been brought into operation vide The Andhra Pradesh Capital City Land Pooling Scheme (Formulation and Implementation) Rules 2015 issued in G.O.Ms.No.1, Municipal Administration & Urban Development (M2) Department, dated 01.01.2015. Under this Scheme an extent of 33,426.00 Acres of Patta Land was given as consent by the Land Owners so far.

2. Rule 4 of Andhra Pradesh Capital City Land Pooling Scheme (Formulation and Implementation) Rules, 2015 stipulates that Government shall proved all the benefits to the affected families under Land Pooling Scheme as listed in Clause I of Schedule III. Sub-para (iii) of Schedule III of the Rules requires to establish skill development institution, and to provide training with stipend to enhance skills for cultivating tenants, agricultural labourers and other needy persons under the Land Pooling Scheme.

3. Towards fulfillment of the above provisions, and with a view to impart training of international standards, and to show placements abroad, Government have requested the Commissioner, AP. Capital Region Development Authority, Vijayawada to survey the Villages of Capital City Area and identify the number of youth who require alternate livelihood in the context of voluntary Land Pooling. Accordingly, the Commissioner, APCRDA, Vijayawada has conducted a house hold survey in all the 29 Villages of Capital City Area and identified that total 3750 persons have interested in undertaking Construction activity and also willing to undergo training in that Sector.

4. The Commissioner, AP. Capital Region Development Authority, Vijayawada has informed to Government vide reference 6th read above that two Oversees Training Centers (OTC) are being run in the Hyderabad which test candidates for Training and placement abroad. Of these two centers, ASV&QXY SKILLS OVERSEAS Training and Testing Center located in Sangareddy, Telangana is identified for Good infrastructure facilities for the proposed program. The OTC of ASV&QXY Pvt. Ltd. has informed that they are importing training with Singapore Standards and will absorb bright candidates in Singapore Companies.

5. The Commissioner, AP. Capital Region Development Authority, Vijayawada has submitted a proposal to Government vide reference 6th read above for training of a pilot batch of 30 candidates with training period of two months. The cost of the training program is estimated to Rs.12,00,000/-@Rs.40,000/- per candidate. It is proposed Stipend of Rs.1,80,000/-@Rs.3000/- per month per candidate payable only on successful completion of the course. Traveling Allowance of Rs.30,000/-@Rs.1000 per candidate is also proposed for to and fro charges for one time as there are no holidays during the training program. The Commissioner, APCRDA, Vijayawada has estimated the total cost of the training program to Rs.14,10,000/-(Rupees Fourteen Lakhs Ten Thousands only) and has requested the Government to issue necessary orders in the matter.

6. Government, with a view to implement the provisions of The Andhra Pradesh Capital Region Development Authority Act, 2014 and The Andhra Pradesh Capital City Land Pooling Scheme (Formulation and Implementation) Rules 2015 and after careful examination of the matter, hereby accord necessary permission to the Commissioner, APCRDA, Vijayawada to take-up and implement the above training program for a pilot batch of 30 candidates with the total cost of Rs.14,10,000/-(Rupees Fourteen Lakhs Ten Thousands only) as proposed in para (5) above duly meeting the above expenditure of Rs.14,10,000/- from the funds of the APCRDA.

7. The Managing Director, Andhra Pradesh Mission for Elimination Poverty in Municipal Areas, AP, Hyderabad shall prepare a Scheme on the above lines for training of all the remaining 3720 candidates identified by the Commissioner, APCRDA, Vijayawada in the 29 Villages of voluntary Land Pooling Scheme as to ensure that no interested candidates from the affected families is left out from getting opportunities for livelihood, and submit the proposals to Government for issuing necessary orders in the matter.
