**ORDER:**

In the reference second read above, the Commissioner, APCRDA, Amaravati has submitted that a meeting of the Three-Men Committee constituted for APCRDA matters, was held on 29.11.2025, wherein the Committee examined certain cases relating to withheld Landless Poor Pension payments and opined that pension payments may be permitted to be transferred to minor orphans of a family, where both parents have died and no adult family member is available. Accordingly, the Commissioner, APCRDA, has requested the Government to accord approval for the same.

2. In the reference 3<sup>rd</sup> read above, the Commissioner, APCRDA has submitted that the 57<sup>th</sup> Meeting of the APCRDA Authority, held on 06.01.2026 and its resolution No.622/2026 has resolved that "Permitting the Commissioner, APCRDA to transfer Landless Poor Pension to the minor children of families where both parents died. Further, he has requested the Government to accord necessary approval for implementation of the decision taken therein.
3. Government, after careful consideration of the matter, and hereby permit the Commissioner, APCRDA to transfer Landless Poor Pension to minor children in the cases where both parents have died and no eligible adult family member is available.
4. The Commissioner, Andhra Pradesh Capital Region Development Authority, Amaravati, shall take further necessary action, accordingly.
