The Government in its orders vide reference 1st, 2nd and 3rd read above have delegated powers vested under certain sections of Andhra Pradesh Urban Areas (Dev) Act, 1975 to the Gram Panchayats in Vijayawada Guntur Tenali Mangalagiri Urban Development Authority jurisdiction.

2. The Government have taken a decision to restore the powers delegated to the Gram Panchayats in order to safeguard the requirements of the proposed new capital city. Accordingly the following notification shall be published in the extraordinary issue of the Andhra Pradesh Gazette Dated: 07.10.2014

NOTIFICATION

In exercise of the powers conferred under Section 36(1) of A.P. Urban Areas (Dev) Act, 1975, the powers of local Panchayats relating to the control on development and use of land and buildings under the Andhra Pradesh Gram Panchayats Act, 1964 are suspended to the extent of areas other than Gram Khantam / Settlement areas of Panchayats falling in Vijayawada Guntur Tenali Mangalagiri Urban Development Authority jurisdiction and accordingly the powers delegated under Section 56 of A.P. Urban Areas (Development) Act, 1975 are restored back to Vijayawada Guntur Tenali Mangalagiri Urban Development Authority relating to the control on Development and use of land and buildings.
