ORDER:

The period of absence of the officers in connection with the above visit including journey time, both ways, shall be treated as on duty, during which the officers will draw their pay and allowances which they would have drawn but for their visit to Singapore. The officers are directed to follow the instructions issued in G.O.Ms.No.124, Finance & Planning, dated 31.08.2000, read with Circular Memo No.528/04/TA/2012, dated 09.02.2012, for drawl of T.A. and D.A., etc.

4. The officers shall submit the visit report to the MA&UD(CRDA.2) Dept., and mark a copy to the Finance/General Administration (SC.E) Department, within one week soon after completion of the visit, with specific and well-defined outputs of the visit that could be adopted for the State of Andhra Pradesh.

5. Sri R. Karikal Valaven, IAS, Principal Secretary, MA & UD Dept., is kept FAC of the post of Principal Secretary to Govt., MA&UD (CRDA) during the foreign visit of Sri Ajay Jain, IAS.

6. The Commissioner, APCRDA shall make necessary in-charge arrangements in respect of other officers.
