ORDER:

In the G.O.3rd read above, the Government constituted a State Level Committee to re-examine and finalize the classification of lands as Jareebu (wet) or Dry in the Capital City villages covering an extent of Ac.202.205 Cts, in accordance with the criteria prescribed in G.O.Ms.No.165, MA&UD (CRDA.II) Department, dated 25.06.2016, adopting 08.12.2014 as the cut-off date.

2. In the reference 4th read above, the District Collector, Guntur, has forwarded the report of the State Level Committee regarding re-examination and finalization of the classification of Jareebu/Dry lands in the Capital City villages, covering a total extent of Ac.202.205 cents, to the Government for further necessary action. Wherein, the State Level Committee examined a total of 88 cases covering an extent of Ac.202.205 cents in five villages, namely Borupalem, Abbarajupalem, Rayapudi, Kondamarajupalem, and Thullur. Out of the 88 cases examined, 71 cases were recommended for classification as Jareebu and 17 cases as Dry, based on field verification, technical evaluation, and documentary evidence.

3. Government, after careful examination of the matter, hereby approve the report and the recommendations of the State Level Committee for re-examination and finalization of the classification of Jareebu/Dry lands in Capital City villages, covering a total extent of Ac.202.205 cents.
