In the reference 1st read above, Finance (Budget) Department, have issued Comprehensive Budget Release Order (CBRO) for the F.Y 2025-26 and allocated budget under the HoA "4217- Capital Outlay on Urban Development - 01 State Capital Development- 051 Construction – 03 Externally Aided Projects- 80 Amaravati Capital City Development Project – 530 Major Works - 531 Major Works" is Rs.6000,00,00,000.00/-

In the reference 2<sup>nd</sup> read above, the Commissioner, APCRDA, Amaravati has requested the Government to issue Administrative Sanction for an amount of Rs.1,400.00 Crores from 2<sup>nd</sup> and 3<sup>rd</sup> quarters provision of the Financial Year 2025-26 under the Head of Account: 4217-01-051-03-80-530-531 VN, Amaravati Capital City Development Project. He has further requested that the Assistant Secretary, MA&UD Department may be authorised as DDO, to draw and credit the amount to the P.D.A/c of APCRDA (Major Head:8443-Civil Deposits – 00-106 Personal Deposits- 03- Externally Aided projects- 04- Urban Development Agencies – 002 APCRDA – 001-Loan from World Bank and ADB) to enable to incur expenditure for implementation of the schemes.
