ORDER:

In the G.O. 1st read above, the Finance (EBS VII-MA&F) Department in Government, have issued BRO for an amount of Rs.1,85,46,000/- under plan from BE provision 2015-16 in relaxation of quarterly regulation towards meeting the expenditure in Municipal Administration & Urban Development Department.

2. In the G.Os 2nd and 3rd read above, have accorded administrative sanction for an amount of Rs.67,90,800/- (Rs.33,70,800/- + 34,20,000/-) under plan from BE provision 2015-16 in relaxation of quarterly regulation towards meeting the invoice amount of IIDC Ltd., Hyderabad for the services extended for the April, May, June and July, 2015 by (3) consultants appointed by them in Andhra Pradesh Capital Region Development Authority for providing Technical Assistance for Project Development of the New Capital City Development program.

3. In the G.O. 4th read above Government, have accorded administrative sanction for an amount of Rs. 34,20,000/- under plan from BE provision 2015-16 for the months of August and September, 2015 by (3) consultants. In the reference 5th read above, the Director of Treasuries & Accounts, A.P., Hyderabad has been requested to issue necessary authorisation for the amount of Rs.34,20,000/-.

4. In the reference 6th read above, the DTA, AP, Hyderabad has stated that as per G.O.Ms.No.36, Finance (BG 1), Dt:02.04.2015, Administrative Sanction order be issued within 90 days from the date of issue of BRO. In the present case, it exceeded the time limit. Hence, returned.

5. The issue has been examined in consultation with Finance department. In the reference 7th read above, the Govt. in Finance (FMU.I&I.EF&MA) Dept. have issued instructions to the Director of Treasuries & Accounts, A.P., Hyderabad to revalidate to the extent of balance amount available in Budget Release Order issued in the reference 1st read above, for taking further necessary action.

6. Government, after careful consideration, hereby accord administrative sanction for expenditure of an amount of Rs. 1,17,55,200/- (Rupees one crore Seventeen lakhs fifty five thousand and two hundred only) under plan from BE provision 2015-16 in relaxation of quarterly regulation towards meeting the expenditure for the services of three (3) consultants for the remaining months of the Financial year 2015-16.

7. Government also hereby accord Administrative sanction for amount of Rs.34.20 (Rupees Thirty four lakhs and twenty thousand only) towards meeting the expenditure for the services of three (3) consultants duly cancelling the orders issued in the G.O 4th read above.
