**ORDER:**

Whereas, an inquiry under Rule-20 of the A.P.C.S. (CC & A) Rules, 1991 is being held against (1) Sri K. Dhanunjaya Reddy, the then Assistant City Planner and (2) Sri K.V. Naga Sastrulu, the then TPBO of Rajamahendravaram Municipal Corporation on the allegation of Irregular sanction of mining lease in Government lands (over 0.43 Acres) in R.s.No.69/2B in Ramdaspet, Rajamahendravaram Municipal limits.

2. Whereas, in the G.Os. 2<sup>nd</sup> read above, orders were issued framing article of charges against the above charged officers.

3. Whereas, in the reference 4<sup>th</sup> read above, Smt. K. Nagasundari, Additional Director of Town & Country Planning (now working in APTIDCO, Vijayawada) was appointed as Inquiring Authority to inquire into the charges framed against the above said officials, with a direction to submit the report within three (3) months.

4. And whereas, it has been reported that in the month of December, 2025, Smt. K. Nagasundari, Inquiring Authority has requested the Presenting Officer to submit the relevant record and also present the case for conduct of the inquiry. In the meanwhile, she was sanctioned 94 days of Child Care Leave from

27.01.2026 to 30.04.2026, followed by 83 days of Half Pay Leave from 01.05.2026 to 22.07.2026, with permission to proceed to USA. In the said circumstances, it has been considered necessary to change the Inquiring Authority for early conclusion of the disciplinary case.

5. Now, therefore, Government, in exercise of the powers conferred by sub-rule (2) of Rule-20 of the A.P. Civil Services (Classification, Control and Appeal) Rules, 1991, hereby appoints Sri B. Suresh Kumar, Additional Director/Principal Planner, APCRDA, Vijayawada as Inquiring Authority in place of Smt. K. Nagasundari, to inquire into the charges framed against the above said officials.

6. The Inquiring Authority shall complete the inquiry as per the provisions of Rule 20 of the A.P.C.S. (CC&A) Rules, 1991 and submit the inquiry report to Government within two (2) months.

7. The Director of Town & Country Planning, A.P., shall provide the copies of required record/material pertaining to the case, such as Articles of Charges, written statements of defence of the Charged Officers and listed documents etc., to the Inquiring Authority, forthwith.

8. The receipt of the G.O. shall be acknowledged.
