ORDER:

The Andhra Pradesh Capital Region Development Authority Repeal Act, 2020 (Act No. 27 of 2020) has come into force w.e.f 31.07.2020 by virtue of Gazette notification issued on 31.07.2020.

2. The following notification will be published in the Extra-ordinary issue of Andhra Pradesh Gazette dated:02.08.2020.

3. The Commissioner, Printing, Stationery and Stores Purchase, Vijayawada shall publish the said notification in the Extra-ordinary issue of Andhra Pradesh Gazette and furnish 150 copies of the notification to the Government.

NOTIFICATION

Whereas the Andhra Pradesh Capital Region Development Authority Repeal Act, 2020 (Act No. 27 of 2020) repealed the Andhra Pradesh Capital Region Development Authority Act, 2014 (Act No. 11 of 2014). Whereas, as per the Section 3 (b) of the Andhra Pradesh Capital Region Development Authority Repeal Act, 2020, the areas within the jurisdiction of AP Capital Region under the Principal Act (AP CRDA Act 2014-Act 11 of 2014), shall be deemed to be the area of the Amaravati Metropolitan Region Development Authority, which shall be notified by the Government on cessation of APCRDA.

2. The Amaravati Metropolitan Region Development Area shall be deemed to be comprising such area as hitherto comprised in the AP Capital region notified under Act 11 of 2014.

3. Further, in exercise of the powers conferred by section 4 (1) & 4(3) of the Andhra Pradesh Metropolitan Region and Urban Development Authorities Act, 2016 (Act No. 5 of 2016), the Government of A.P. hereby constitute and notify Amaravati Metropolitan Region Development Authority (AMRDA) and with the following members, namely,-
