In the circumstance reported by the Commissioner, APCRDA in the reference read above, the Government after careful examination of the matter hereby accords permission to the Commissioner, Andhra Pradesh Capital Region Development Authority (APCRDA), Vijayawada, to secure loan of Rs.7,387.70 Crores from National Bank for Agriculture and Rural Development (NABARD) for implementation of various infrastructure projects in the Amaravati Capital Region of Andhra Pradesh under the NABARD Infrastructure Development Assistance (NIDA) Scheme and accords approval for availing the loan sanctioned by NABARD under the terms and conditions specified in the sanction letter, subject to payment of 5% guarantee fee.

The Government further authorizes the Commissioner, Andhra Pradesh Capital Region Development Authority (APCRDA), Vijayawada, or any APCRDA official duly authorized by the Commissioner, APCRDA to obtain the State Government Guarantee and Letter of Comfort from the Finance Department, Government of Andhra Pradesh, towards providing security for the NABARD loan amounting to Rs.7,387.70 Crores, and to execute the Loan Agreement, and all other necessary acts and deeds for implementing the decisions of the Authority.

3. The Commissioner, Andhra Pradesh Capital Region Development Authority, Vijayawada shall take further necessary action, accordingly.
