After careful examination of the matter, the Government hereby accords Administrative Sanction for an amount of Rs.165.33 Crores (Rupees One Hundred Sixty Five Crores and Thirty Three Lakhs only) towards the work, “Construction of Andhra Pradesh Judicial Academy with Pile Foundation, Super Structure with RC Columns - Beams Framed Structure, Architectural Finishes, Internal Electrical & Plumbing works, HVAC works and IT works including External Electrical, Plumbing, Infrastructure Facilities, Internal Roads”, for Andhra Pradesh Judicial Academy in Prime location of Sports City, Amaravati Capital City, Pitchikalapalem Village, Amaravati, Andhra Pradesh including DLP of 2 Years, and calling for tenders under the Lumpsum (% Percentage Tender) Contract System , subject to condition that (i) No State budgetary support or guarantee is involved, unless separately approved; (ii) Deletion of LS provisions towards consideration amount and price adjustment.
