ORDER:

In the circumstances reported by the Municipal Admn., & Urban Development Dept., in the reference read above, permission is hereby accorded to Dr. Sreedhar Cherukuri, IAS, Commissioner, AP CRDA, Vijayawada to visit Washington D.C., USA from 19th to 23rd March 2018 (excluding journey period) to present the paper on Amaravati Capital City Land Pooling Scheme in the 2018 World Bank Conference on Land and Poverty, which will be taken place at World Bank Head quarters. The Officer shall obtain political clearance before undertaking the visit. Commissioner's travel and accommodation expenditure will be borne by the World Bank. The registration fee of USD \$400 to attend the Conference has to be borne by APCRDA. The visit of the officer is subject to obtaining necessary clearances from Government of India and also subject to regulation (rescheduling/short-cutting/cancelling) owing to official exigencies when the presence of the officer is considered essential for discharge of his official duties before the schedule departure.

The period of absence of the officer in connection with the above visit including journey time, both ways, shall be treated as on duty, during which the officer will draw his pay and allowances which he would have drawn but for his visit to USA. The officer is directed to follow the instructions issued in G.O.Ms.No.124, Finance & Planning, dated 31.08.2000, read with Circular Memo No.528/04/TA/2012. Dated 09.02.2012, for drawl of T.A. and D.A., etc.

3. The officer shall submit a report of his visit to the Municipal Admn., & Urban Development Dept., and furnish a copy to the Finance/General Administration Department, within one week soon after completion of the visit, specific with well-defined outputs of the visit that could be adopted for the State of Andhra Pradesh.

4. The Prl. Secretary to Government, Municipal Admn., & Urban Development Dept., shall make necessary in-charge arrangements for the post of the Officer during the above visit.
