ORDER:-

In the reference 1<sup>st</sup> read above, the Ministry of External Affairs, East Asia Division has circulated an Office Memorandum to all the concerned informing serving Government Officials to apply for the Liaison Officer, Kailash Manasarovar Yatra-2018. Accordingly, Shri V. Rama Manohara Rao, IRAS, Special Commissioner, O/o Andhra Pradesh Capital Region Development Authority, Vijayawada, has applied as Liaison Officer (LO) to the Kailash Manasarovar Yatra-2018, and the same has been forwarded by the CRDA to the Under Secretary, Ministry of External Affairs, New Delhi, vide reference 2<sup>nd</sup> read above.

2. In the reference 3<sup>rd</sup> read above, the Commissioner, Andhra Pradesh Capital Region Development Authority, Vijayawada has requested the Government to give Administrative approval to Sri V.Rama Manohara Rao, IRAS, for Liaison Officer, Kailash Manasarovar Yatra - 2018 duty, Admissible expenditure for the duty as Liaison Officer to be borne by APCRDA, and sanction of applicable leaves and consequent relief from official duty if the officer is selected as Liaison Officer and entitlement of 100% full DA to the Officer on his journey on duty abroad as per applicable rates.

3. After careful examination of the matter, Government, hereby accord permission to Sri V. Rama Manohara Rao, IRAS, Special Commissioner, O/o APCRDA, Vijayawada to act as Liaison Officer for the Kailash Manasarovar Yatra-2018 along with the assigned batch for 25 to 30 days, by sanctioning Special Casual Leave/meeting the admissible expenditure by APCRDA and payment of Entitled 100% full DA on his journey on duty abroad as per applicable rates.

4. The Commissioner, APCRDA is authorized to sanction the Special Casual Leave and relief of the Officer, on his selection as Liaison Officer, by making internal arrangements of the post of being held by the Officer.

5. The Commissioner, Andhra Pradesh Capital Region Development Authority (CRDA), Vijayawada shall take necessary further action in the matter.
