ORDER:-

In the reference read above, the Director General of Police, Andhra Pradesh, Hyderabad has stated that Andhra Pradesh Police Academy (APPA) was established in Andhra Pradesh in 1986. It has been serving as a nodal agency and as an institution of higher learning for police and other law enforcement agencies including Forensic Scientists and Public Prosecutors. The Academy was developed as a model training Academy in the State of Andhra Pradesh. There is urgent need for establishing a State Level Police Academy for the State of Andhra Pradesh for imparting induction training and in-service training courses to the officers of A.P. Police from the rank of IPS to the rank of Sub-Inspectors of Police. Andhra Pradesh Police Academy (APPA) is listed as Schedule X Institution under A.P. Re-organisation Act, 2014 in view of the bifurcation of the State. There is need to replicate similar facility in Residual Andhra Pradesh pending bifurcation of Andhra Pradesh Police Academy (APPA), Hyderabad. The Director General of Police has further also informed that building up a full-fledged Police Academy may take 2-3 years before it can take trainees.

2. The Police Training College, Ananthapuramu is a Training Institution for Police Constables. It was initially established as Police Recruits School in 1917 and later upgraded as Police Training College in 1955. Induction training courses of direct recruit DSPs and SIs/RSIs and in-service training courses of Police Officers of entire Andhra Pradesh State were conducted in PTC, Ananthapuramu till Andhra Pradesh Police Academy, Hyderabad was fully established.

3. Hence, it is suitable to serve the purpose for the time being. The Director General of Police, Andhra Pradesh, Hyderabad has therefore, requested the Government to designate temporarily the Police Training College, Ananthapuramu as the State Level Police Academy for Andhra Pradesh State (Andhra Pradesh Police Academy, Ananthapuramu) with a Director in the rank of IGP / ADGP till the new Police Academy is established in CRDA area or otherwise.

4. Government after careful examination, hereby temporarily designate the Police Training College, Ananthapuramu as the State Level Police Academy for Andhra Pradesh State (Andhra Pradesh Police Academy, Ananthapuramu) with a Director in the rank of IGP / ADGP to head the Academy till a new Police Academy is established in CRDA area or otherwise.
