ORDER:

In the G.O 1st read above, Government have issued the AP Capital City Land Pooling Scheme (Formulation and Implementation) Rules, 2015, wherein the Rule 5(3) has prescribed that the Government shall provide pension of two thousand five hundred rupees per month per family for a period of ten years to all landless families through a capital region social security fund.

2. In the reference 2nd read above, the Commissioner, Andhra Pradesh Capital Region Development Authority, Vijayawada has stated that Socio Economic Survey was conducted in the Capital City area and as per the enumeration, 23500 landless families are found eligible for payment of Rs.2,500/- per month for a period of 10 years and requested for release of Rs. 70.50 crores for the financial year 2015-16. As per Rule 5(3) of the AP Capital City LPS (F&I) Rules, 2015, the Government shall provide pension of Rs.2,500/- per month per family for a period of 10 years to all the landless families through a Capital Region Social Security Fund and requested the Government to provide necessary budget for allocating funds for disbursement of 1st installment pension.

3. In the reference 3rd read above, the Commissioner, Andhra Pradesh Capital Region Development Authority has further requested the Government to provide an amount of Rs.17.63 (Rupees Seventeen Crores and sixty three lakhs only) crores towards quarterly installment for the FY 2015-16 to the District Collector, Guntur for disbursement of monthly installment of pensions to the landless families and also requested the Government to open a separate head of account with the title "Capital Region Social Security Fund".

4. In the reference 4th read above, the Finance Department have created a head of account:"4217-01-050-GH.11.NSP-SH(08) Capital Region Social Security Fund - 310/312 other Grants-in-aid" towards payment of

pension to landless families in Capital Region as per "Rule 5(3) of the A.P Capital City Land Pooling Scheme (Formulation and Implementation) Rules, 2015".

5. Government, after careful examination of the matter, hereby accord administrative sanction for implementation of the scheme of payment of pension of Rs.2,500/- per month, per family for a period of 10 years to the eligible landless families as identified with reference to the Rule 5(3) of the A.P Capital City Land Pooling Scheme (Formulation and Implementation) Rules, 2015 in Capital City Area and rules in force. The new scheme shall be operated through the head of account:"4217-01-050-GH.11.NSP-SH(08) Capital Region Social Security Fund - 310/312 other Grants-in-aid".

6. The Commissioner, Andhra Pradesh Capital Region Development Authority, Vijayawada shall formulate operational guidelines for implementation of the scheme and send necessary proposals to the Government for approval.
