ORDER:

The Government of Andhra Pradesh enacted Andhra Pradesh Capital Region Development Authority (APCRDA) Act, 2014 (Act.No.11 of 2014) and notified Capital Region covering an area of 7,068 Sq.Kms and Capital City area covering an area of 122 Sq.Kms between Vijayawada and Guntur of Andhra Pradesh. Accordingly, the AP Capital Region Development Authority was constituted for capital region for administering capital region and for construction and management of capital city.

2. The Andhra Pradesh Capital Region Development Authority Act has several salient design principles that make it empowered to ensure that the capital region is developed and governed in a world – class manner. Hence, the correct interpretation of the act provisions and implementation of the APCRDA is crucial to ensure its success of the entire capital region. Further the APCRDA needs to be setup to meet or exceed the high aspirations of citizens/ political leadership have for the capital region/ city and have the world class capability to attract Global investors/ anchors.

3. In the reference 1st read above the Commissioner, Capital Region Development Authority has informed that McKinsey & Company has been engaged with Infrastructure Corporation of Andhra Pradesh Ltd., and assisted the advisory committee meetings on capital city since 26th July, 2014 onwards and helped to develop the thinking on the framework of the Act, the governance structure, the way ahead for the construction of the capital city based on a socio-economic plan for a livable city. The Managing Director, Infrastructure Corporation of Andhra Pradesh Ltd., informed that McKinsey & Company had been assisting free of cost till date. Further the McKinsey & Company consistently finds place amongst the top three consulting firms globally by various agencies such as Forbes magazine.
