ORDER:

In the reference 1st read above, the Andhra Pradesh Capital Region Development Authority Act, 2014 has been enacted vide Act No.11 of 2014 and the provisions of the Act came into force from 30.12.2014.

2. Whereas in the reference 2nd read above, the Government have issued orders constituting the Andhra Pradesh Capital Region Development Authority with Hon'ble Chief Minister as Chairman by ceasing the existing Vijayawada, Guntur, Tenali and Mangalagiri Urban Development Authority, Vijayawada with immediate effect.

3. Whereas in the reference 3rd read above, the Government have constituted an Executive Committee with Principal Secretary to Government, Municipal Administration & Urban Development Department, as Chairman of the Authority along with two others members.

4. The Andhra Pradesh Capital Region Development Authority Act, 2014 provides feasibility for Change of land use i.e., modification to the sanctioned Development plans, Master plans and Infrastructure plan within the jurisdiction of Capital Region Development Authority by the Authority and the procedure for modifications is prescribed in Section 41 of Andhra Pradesh Capital Region Development Authority Act, 2014.

5. Accordingly, as per the Andhra Pradesh Capital Region Development Authority Act, 2014 provisions, the Government is empowered to make rules u/s 18 of the Act to carry out the functions of the Authority and the purpose of the Act. For the purpose of examining the modifications / Change of Land Use proposals within Capital Region Development Authority, a Change of Land Use (CLU) Committee under the Chairmanship of Chairman, Executive Committee of Capital Region Development Authority with following composition is hereby constituted.
