**ORDER:**

The Government, in the G.O 1<sup>st</sup> read above, accorded administrative approval to the Vijayawada, Guntur, Tenali, Mangalagiri Urban Development Authority (VGTM-UDA), to take up the work of construction of RUB beside existing ROB at Km.431/8-10A in Singh Nagar area of Vijayawada City, with an amount of Rs.3.75 crores.

2. The Vice-Chairman, erstwhile Vijayawada, Guntur, Tenali, Mangalagiri Urban Development Authority (VGTM-UDA), vide letter 2<sup>nd</sup> read above has informed that, earlier, Government have accorded the Administrative approval for Rs. 3,75,00,000 based on the tentative estimated cost furnished by the South Central Railways. Now the South Central Railways Vijayawada has submitted revised Estimate for Rs.6,43,84,897/- for the construction of RUB in Singh Nagar area of Vijayawada City and requested to accord Revised Administrative approval to deposit the same with the South Central Railways.

3. The Government after careful examination of the matter, hereby accord approval for Revised Administrative sanction of Rs. 6,43,84,897/- to deposit the amount with the South Central Railways for taking up of construction of RUB beside existing ROB at Km.431/8-10A in Singh Nagar area of Vijayawada City.

4. The Commissioner, Andhra Pradesh Capital Region Development Authority, Vijayawada shall take further action accordingly, in consultation with the South Central Railway authorities.
