5. Prl. Secretary to Govt to APCRDA – Member Convener

4. The Principal Secretary to Government, CRDA shall be the convener of the above Group of Ministers and Principal Finance Secretary, Principal Secretary, Health, Medical & Family Welfare and Principal Secretary, Higher Education, will assist the Group of Ministers.

5. The Group of Ministers shall furnish it's recommendations to the Government for taking a decision in the matter.
