ORDER:

Government, in the G.O 2nd read above, constituted Andhra Pradesh Capital Region Development Authority (APCRDA) for the purpose of Planning, Co-ordination, Execution, Supervision, Financing, Funding and for Promoting and Securing the Planned Development of the Capital Region and Capital City Area for the State of Andhra Pradesh and for managing and supervising urban services in the New Capital Area and for the matters ancillary thereto.

2. Government, in the G.O 3rd read above, constituted Executive Committee of APCRDA, as per the provisions of sub-section (1) of Section (6) of APCRDA Act, 2014 and informed that the Government will issue separate orders nominating the other secretaries or heads of government departments as and when need arises.

3. In the G.O 4th read above, Government have notified Sri Ajay Jain, IAS (1991), Secretary to Government, Energy, Infrastructure and Investment Department shall also be the Secretary to Government (CRDA), Municipal Administration & Urban Development Department.

4. In the letter 5th read above, the Commissioner, APCRDA has requested the Government to nominate the other Secretaries or Heads of Government Departments as per provisions of Section 6(1)(d) of the APCRDA Act, 2014, mentioned therein.

5. After careful examination of the matter, Government hereby decide to reconstitute Executive Committee under the Chairmanship of Secretary, MA&UD (CRDA) Department. Accordingly, the following notification shall be published in the Extra-ordinary issue of Andhra Pradesh Gazette
Dated:22.09.2015.
