ORDER:

In the reference 1st read above, the Commissioner, APCRDA, has requested the Government to sanction and release an amount of Rs.118.86 crores as additional funds towards annuity payments so as to regularize and recoup the amount of Rs.104.50 crores withdrawn from the P.D.A/c and to meet the further requirement of Rs.14.36 crores, in relaxation of Treasury Control and quarterly regulations subject to obtaining of supplementary estimates before the end of the financial year, as the expenditure does not relate to any construction activity and the amount has to be paid to the farmers direct under the scheme of payment of annuity payments to the farmers, who have parted their land, as guaranteed under Land Pooling Scheme.

In the reference 2nd read above, the Finance (FMUI- I,EF,MA) Department have issued Budget Release Order for an amount of Rs.118,86,00,000/- (Rupees One Hundred Eighteen Crores Eighty Six Lakhs only) as additional funds in relaxation of Treasury Control & Quarterly Regulation orders pending submission of Supplementary Estimates during current Financial Year towards annuity payments to the

Government also hereby release an amount of Rs.118,86,00,000/- (Rupees One Hundred Eighteen Crores Eighty Six Lakhs only) for the financial year 2016-17, under Head of Account:- "2217-01-800-11-05-310-Grants-In-Aid, 312 other Grants-In-Aid(Voted)" as additional funds in relaxation of Treasury Control & Quarterly Regulation orders pending submission of Supplementary Estimates during current Financial Year towards annuity payments to the land owners who parted their lands under Land Pooling Scheme(LPS) for the State New Capital.

The Assistant Secretary to Government (Drawing Officer) Municipal Administration & Urban Development Dept., Andhra Pradesh, Hyderabad shall draw the amount sanctioned in para(4) above and credit the amount to the P.D account of APCRDA(i.e., Major Head:8448- Deposits of local funds, Minor Head:120-Other Funds, S.H.19- Commissioner, APCRDA, Vijayawada).

6. The Director of Treasuries and Accounts, Andhra Pradesh, Hyderabad is requested to issue authorization for the amount sanctioned in para(4) above.
