**ORDER:**

In the reference 1<sup>st</sup> read above, orders were issued under schedule III(1)(iii)(a) of the A.P. Capital City Land Pooling Scheme (Formulation & Implementation) Rules,2015, the APCRDA Act,2014 guarantees to provide free education facilities to all the residents of the Capital City area, residing as on the date of 08.12.2014.

**2.** In the reference 2<sup>nd</sup> read above, orders were issued to implement the scheme through B C Welfare Department and Commissioner, APCRDA has to release the budget to the B C Welfare Department after obtaining funds from Municipal Administration and Urban Development Department. Accordingly arrangements were made to implement the scheme through E PASS of the Centre for Good Governance. The registration process of enrolment was completed and scrutiny of the candidates is underway for release of budget for fee reimbursement to the students and this office has to release the budget to the B C Welfare Department for the Academic year 2016-17 during the current financial year i.e., 2017-18.

**3.** According to operational guidelines , the definition for eligible students is the students who are residents as on 08<sup>th</sup> December,2014 in the Amaravati Capital City Area, irrespective of the parental income or community, studying in the eligible colleges, and not already covered under other categories such as Scheduled Castes/Scheduled Tribes/Backward classes/Minorities/Physically challenged.

**4.** In the reference 3<sup>rd</sup> read above, Finance (FMU-I-I,EF,MA) Department, among others, have issued Comprehensive Budget Release Orders for an amount of Rs.70,50,00,000/- from the BE Provision 2017-18 and apportioned the approved Budget towards meeting the expenditure through Capital Region Social Security Fund in which the scheme of Free Education to all the Residents of Capital City Area is included.

**5.** In the reference 5<sup>th</sup> read above, the Commissioner, APCRDA, Vijayawada, has requested to sanction and release an amount of Rs.95,00,000/- (Rupees Ninety Five Lakhs only) to meet the immediate requirement during the financial year 2017-18, under the **Head of Account (2217-01-800-GH11-SH(08)-310-312)**, and the amount may be credited to the **P.D.A/c of APCRDA(8448-00-120-00(19)-000-000)**.

**6.** Government after careful examination of the matter hereby sanction and release an amount of Rs.95,00,000/- (Rupees Ninety Five Lakhs only) to meet the immediate requirement during the financial year 2017-18 under the following Head of Account, and the amount may be credited to the **P.D.A/c of APCRDA (8448-00-120-00(19)-000-000)** to ensure prompt release of funds to the DBCWO, Guntur District of BC Welfare Department for implementation of the scheme.
