ORDER:

In the reference 1st read above, orders were issued under schedule III(1)(iii)(a) of the A.P. Capital City Land Pooling Scheme(Formulation & Implementation) Rules,2015, the APCRDA Act,2014 guarantees to provide free medical facilities to all the residents of the Capital City area, residing as on the date of 08.12.2014.

2. In accordance with the GO 2nd read above, the scheme of “Cashless Health Care Policy of Amaravati” shall be applicable to all the residents of Capital City Area including the residents covered under other existing schemes. The scheme shall be implemented by Dr.NTR Vaidya Seva Trust and the budget required for implementing the scheme shall be allocated under the Budget of MA&UD (CRDA) Department and paid to Dr.NTR Vaidya seva Trust.

3. According to the Commissioner, APCRDA, that as the scheme of Providing medical facilities to all the residents of capital city area includes the residents covered under other existing schemes, the number of residents raises to 1,10,326 approximately (36740 families x 3 members) to be covered under the scheme. The amount of requirement for the financial year 2017-18 has been estimated and it comes to Rs.3,30,00,000/-

4. In the reference 3rd read above, Finance (FMU-I-I,EF,MA) Department, among others, have issued Comprehensive Budget Release Orders for an amount of Rs.70,50,00,000/- from the BE Provision 2017-18 and apportioned the approved Budget towards meeting the expenditure through Capital Region Social Security Fund in which the scheme of Free medical facilities to all the Residents of Capital City Area is included.

5. In the reference 6th read above, the Commissioner, APCRDA, Vijayawada, has requested to sanction and release an amount of Rs.3,30,00,000/- (Rupees Three crore thirty Lakhs only) to meet the immediate requirement during the financial year 2017-18, under the Head of Account **(2217-01-800-GH11-SH(08)-310-312)**, and the amount may be credited to the P.D.A/c of **APCRDA(8448-00-120-00(19)-000-000)**.

6. Government after careful examination of the matter hereby accord Administrative sanction for implementation of the scheme of free medical facilities , sanction and release an amount of Rs.3,30,00,000/- (Rupees Three crore thirty Lakhs only) to meet the immediate requirement during the financial year 2017-18 under the following Head of Account, and the amount may be credited to the P.D.A/c of **APCRDA (8448-00-120-00(19)-000-000)** to ensure prompt release of funds to the CEO, Dr.NTR Vaidya Seva Trust, Guntur District for implementation of the scheme.
