**ORDER:**

In the circumstances reported by the MA & UD (CRDA.1) Department in the reference read above, permission is hereby accorded to Dr. Sreedhar Cherukuri, IAS, Commissioner, APCRDA, Vijayawada, and Sri R. The period of absence of the officers in connection with the above visit including journey time, both ways, shall be treated as on duty, during which the officers shall draw their Pay and allowances which they would have drawn but for their visit to London, United Kingdom. The officers are directed to follow the instructions issued in G.O.Ms.No.124, Finance & Planning, dated: 31.08.2000, read with Circular Memo No.528/04/TA/2012, Dated 09.02.2012, for drawal of T.A. and D.A., etc.

3. The Commissioner, APCRDA shall submit a report of visit to the MA&UD (CRDA.1) Department and furnish a copy to the Finance/General Administration Department within one week soon after completion of the visit, specific with well-defined outputs of the visit that could be adopted for the State of Andhra Pradesh.

4. The MA&UD (CRDA.1) shall make necessary in-charge arrangements for the posts held by the officers during the above period.
