ORDER:

In the reference 1st read above, orders have been issued constituting Group of Ministers (GoM) to examine the issue of allocation of land to various Institutions, in the Capital City Region.

2. In the reference 2nd read above among others, orders have been issued allotting land to an extent of Ac.5.00 cents to Rama Krishna Mission @ Rs.10 lakhs per acre on Leasehold basis for a period of 60 years outside capital city within CRDA.

3. The Commissioner, Andhra Pradesh Capital Region Development Authority(APCRDA) in the reference 3rd read above, has informed that the Secretary, Rama Krishna Mission has requested to allot land to an extent of Ac.10.00 cents @ Rs.10 lakhs per acre on Freehold basis with in the Capital City.

4. The Group of Ministers (GoM) in its 9th meeting held on 24.10.2018, have discussed the issue and made recommendations regarding allotment of land to an extent of 5 acres @ Rs.10 lakhs per acre on freehold basis with in capital city Amaravati to Rama Krishna mission in line with Brahmakumari's.

5. Government, after careful examination in the matter, hereby issue order for allotment of land to Rama Krishna Mission to an extent of Ac.2.50 cents at Rs.10 lakhs per acre on Freehold basis with in capital city of Amaravati duly modifying the earlier orders issued in the reference 2nd read above.

6. The Commissioner, Andhra Pradesh Capital Region Development Authority, Vijayawada, shall scrupulously follow all other relevant rules and regulations while allocating the land and entering Agreement and take necessary action accordingly.
