5. The Terms of Reference of the Group of Ministers as proposed by the MA& UD Department are as follows:

- a) Review previous allotment and decide on the continuation of existing allottees.

- b) Assess the extent of land previously allotted and consider any necessary changes.
- c) Examine and evaluate new requests for land allotments.
- d) Identify World-Class Organizations across various sectors and provide the necessary support to establish a significant presence in Amaravati.

6. The Group of Ministers shall monitor the overall progress of the land allocation of various Institutions in CRDA Region as envisaged by the Government of Andhra Pradesh.

7. The Group of Ministers shall submit their recommendations to the Government for taking a decision in the matter.
