In the ref. read above, the Commissioner, CRDA has submitted that in order to facilitate easy movement of VIPs, Staff and Visitors, the lifts installed in Secretariat Buildings: 1 -6 must be in operating condition and all the lifts must be under Annual Maintenance Contract and in this regard he has requested to accord administrative sanction for the work "Annual Maintenance Contract to the Johnson make Lifts installed in buildings 1 to 6 at IGC, AP Secretariat" for an estimated amount of Rs.12,50,000/- (Rupees Twelve Lakh Fifty Thousand Only) for a period of twelve months and to accord permission to call for tenders.

After careful examination of the proposal, Government hereby accord administrative sanction to the Commissioner, CRDA for an estimated amount of Rs.12,50,000/- (Rupees twelve lakh fifty thousand only) for the work "Providing Comprehensive Annual Maintenance Contract to the lifts of Johnson make installed in buildings 1 to 6 at IGC, AP Secretariat" for a period of twelve months and also permitted to call for fresh tenders, under the Head of Account "2059-01-053-00- 10-270-272".
