**O R D E R :**

In the reference G.O.1<sup>st</sup> read above, Government have issued the "Mangalagiri Gold Cluster Land Pooling Scheme (Formulation & Implementation) Rules, 2025 for implementation of the Land Pooling Scheme in respect of the Mangalagiri Gold Cluster over an extent of Ac.78.01 cents at Atmakur Village, Mangalagiri, intended for establishment of a Gems & Jewellery Park.

2. In the reference 2<sup>nd</sup> read above, the Commissioner, APCRDA has submitted that as per Rule 5(1) of the Mangalagiri Gold Cluster Land Pooling Scheme (F&I) Rules, 2025, upon requisition by the Commissioner, APCRDA / District Collector, Guntur, the Government shall appoint a Competent Authority in the cadre of Sub-Collector / Deputy Collector to implement the Scheme under the functional and administrative control of the District Collector, Guntur.

3. The Commissioner, APCRDA has further stated that the Competent Authority is required to discharge responsibilities from the stage of declaration of intention up to the issue of Land Pooling Ownership Certificate (L.P.O.C.) in accordance with the provisions of the said Rules. Accordingly, he has requested the Government to appoint the Sub-Collector, Tenali as the Competent Authority for the Mangalagiri Gold Cluster Land Pooling Scheme.

4. Government, after careful examination of the matter, hereby appoint the Sub-Collector, Tenali as the Competent Authority for the Mangalagiri Gold Cluster Land Pooling Scheme, in terms of Rule 5(1) of the Mangalagiri Gold Cluster Land Pooling Scheme (Formulation & Implementation) Rules, 2025.
