ORDER:-

In the reference G.O.1st read above, Government accorded Administrative Sanction to the Andhra Pradesh Capital Region Development Authority (APCRDA) for an amount of Rs.286.20 Crore (Rupees Two Hundred Eighty-Six Crore and Twenty Lakhs only) towards the work of Desilting of Sand from the foreshore of Prakasam Barrage at different reaches of River Krishna, and permitted to invite tenders under the Lumpsum Contract (% Percentage Tender) system. The APCRDA was authorized to undertake the said work on behalf of the Water Resource Department, and shall proceed accordingly, subject to obtaining approvals from the concerned departments, as stipulated in the said G.O.

- 2. In the reference 2^{nd} read above, the Commissioner, APCRDA has stated that, on technical grounds, the nomenclature of the work requires modification from "desilting of sand from foreshore of the Prakasam Barrage" to "desilting foreshore of the Prakasam Barrage," and accordingly requested that the nomenclature mentioned in the G.O.1st read above be modified.
- 3. After careful examination, the Government hereby approves the modification of the nomenclature of the work as "desilting foreshore of the Prakasam Barrage" in place of "desilting of sand from foreshore of the Prakasam Barrage", issued in the $G.O.1^{st}$ read above.

4. The Commissioner, Andhra Pradesh Capital Region Development Authority, Vijayawada shall take further necessary action, accordingly.
