2. The Terms of Reference of the State Level Committee are as follows :-

- (i) To conduct field enquiry on classification of Jareebu /Dry lands covering an extent of 202.205 Acres in the villages of Capital City as determined by District level Committee headed by the Special Collector (LA), Dr.K.L.Rao Sagar (Pulichintala) Project, Guntur, as per the guidelines prescribed in G.O.Ms.No.165, dated: 25-06-2016 of MA&UD (CRDA-II) Department.
- (ii) The Verification of the lands shall be done as per the criteria already defined and with the cutoff date of 08.12.2014, Satellite images on the cutoff date shall be adopted for deciding whether borewells are existing on the said lands.
- (iii) Any other work as entrusted by the District Collector, Guntur in this regard.
