2. The Terms of Reference of the District Level Committee are as follows:-

- (i) Enquiry & Verify by means of a field-level enquiry, whether all exemptions granted for extents exceeding 10 Cents outside Gramakantam (original village habitation) under 9.2 are in strict conformity with the guidelines issued in Circular I & Circular II.
- (ii) Enquire in to the grievances submitted to APCRDA and their eligibility in terms of Circular I & Circular II.
- (iii) Take up verification of any new grievances filed before the committee.
- (iv) Submit report within 60 days from date of issue orders.
