After careful examination of the matter, the Government hereby accords "Administrative Sanction for an amount of Rs.109.52 Crore towards the Additional works including enhanced storage, structural add-ons, upgraded amenities, and expanded HVAC and electrical systems for the AIS Principal Secretaries and Secretary Bungalows", at Amaravati Capital City, Rayapudi Village, Amaravati, Andhra Pradesh including DLP of 2 Years, and to permit calling of tenders under the Lumpsum (% Percentage Tender) Contract System, subject to the following conditions :-

- i) Limit the expenditure incurred towards unforeseen items of work to 2% of estimate value of work, as per para 117(A) of APPW 'D' Code.
- (ii) Conforming to Department Codes.
- (iii) The expenditure incurred towards LS provisions shall be limited to actual only. Any savings accrued against LS provisions shall not be utilised to any other items.

3. The Commissioner, Andhra Pradesh Capital Region Development Authority, Vijayawada shall take further necessary action, accordingly.
