Also "RESOLVED THAT" permission is hereby accorded to issue Letter of Acceptance to M/s LARSEN & TOUBRO LIMITED for Rs.103.96Cr. (excluding taxes) i.e 4.36% excess over Approved Project Cost. "RESOLVED FURTHER THAT the

		Commissioner, APCRDA is hereby authorized to carry out all the necessary acts and deeds for implementing the decision of the Authority."

2. After careful examination of the matter, the Government hereby accords Administrative Sanction for an amount of Rs.137.00 Crores towards the work "Design-Build of Amaravati Quantum Computing Centre (AQCC) at Amaravati Capital City, Andhra Pradesh". The expenditure shall be met from APCRDA Funds, subject to the following conditions:

- (i) The total cost of ₹137.00 Cr shall be booked under APCRDA funds as indicated by APCRDA.
- (ii) LS provision towards unforeseen works shall be capped at 2% and strictly regulated.

3. Further, the Government hereby authorizes the Commissioner, Andhra Pradesh Capital Region Development Authority, Vijayawada, to issue the Letter of Acceptance to the L1 bidder towards the work "Design-Build of Amaravati Quantum Computing Centre (AQCC), Amaravati Capital City, Andhra Pradesh" at a contract value of Rs.103.96 Crores (excluding taxes), i.e., 4.36% excess over Approved Project Cost Rs.99.62 Cr in favour of M/s LARSEN & TOUBRO LIMITED, subject to condition that, no further price escalation beyond the 4.36% premium shall be entertained except under GCC norms, and to take all necessary actions for implementation of the decision as approved by the APCRDA Authority vide Resolution No. 613/2025, dated 22.12.2025.

4. The Commissioner, Andhra Pradesh Capital Region Development Authority, Vijayawada shall take further necessary action, accordingly.
