ORDER :

In the reference 1st read above, Government have declared the Amaravati Capital City area admesuring 217 Sq.KM, covered in 29 villages with the population around 1.00 Lakh and Interim Government Complex built in the Velagapudi village and started functioning from October 2016.

2. In the reference 2nd read above, the Commissioner, Andhra Pradesh Capital Region Development Authority, Vijayawada, has informed that there are about 29 Panchayats in the Capital City and they have little manpower and monetary resources are there to take care of the village sanitation and also up keeping the roads that are leading to Interim Government Complex(IGC). Presently, in Amaravati capital city, the infrastructure and sanitation facilities were being maintained by District Panchayat Office. There are several representations are being received from the public representatives for the improvements of Infrastructure like Roads, Drains and sanitation in the existing villages. Further, the Commissioner, Andhra Pradesh Capital Region Development Authority, Vijayawada, has stated that if, sanitation and development of the villages has take care, they have requires a dedicated team headed by an experienced person who has well experience of handling sanitation and development of Village Level Infrastructure to meet the immediate requirement, to safeguard the health interests of people of 29 Villages of Amaravati Capital city area, as the Sanitation has become a prime aspect. It is also necessitated to keep the area clean & healthy as delegates of different countries visiting the area to take part in building of Amaravati, an International city. There is an immediate necessity to improve sanitation standards in 29 villages of Amaravati Capital City Area. It is also required to manage the solid waste produced in these villages to have ZERO waste duly following the standards set by the Government vide G.O.Ms.No.279, MA&UD(B2)Department, dt.3.12.2015.

3. After careful examination of the proposal, Government hereby permit the Commissioner, Andhra Pradesh Capital Region Development Authority, to form a unit office in APCRDA Region in Thulluru under the Control of Project Officer in the cadre of Special Grade Municipal Commissioner or any officer of similar cadre and experience supported by the pattern of the staff of Engineering and Sanitary wings for various departments for development and maintenance of infrastructure and sanitation in the 29 villages for implementation of the infrastructure and Sanitation facilities :-

A) Engineering Wing:

1. Executive Engineer - 1 No
2. Deputy Executive Engineer - 1 Nos
3. Assistant Executive Engineer / Assistant Engineers - 2 Nos

B) Sanitary Wing (Health):

1. Health officer - 1 No

3. Sanitary inspectors - 4 Nos
