ORDER:

In the G.O 1st read above, the Government in Youth Advancement Tourism & Culture (Sports/YS) Department, have issued orders for sanction of 1000 Sq. Yds. Of Residential plot to Kum. P.V.Sindhu at Amaravati.

2. In the reference 2nd and 3rd read above, orders were issued allotting land to an extent of Ac.88.40 cents to Seventeen(17) Organizations of Government of India Departments/Public Sectors undertakings/Corporations, Government of Andhra Pradesh Departments/Public Sector undertakings/Corporations, Private Organizations and individual in Capital Region Development Authority Region including allotment of Ac.0.20 Cts of Residential plot to Kum. P.V. Sindhu in Amaravati.

3. In the reference 4th read above, the Commissioner Andhra Pradesh Capital Region Development Authority(APCRDA), has informed that the Government of Andhra Pradesh vide G.O.Ms.No.281, MA&UD(CRDA-2) Department, Dt:21.07.2017, and also vide G.O.Ms.No.369, MA&UD(CRDA-2) Department, Dt:18.10.2017 have issued orders for sanction of Ac.0.20 Cts of Residential plot to Kum. P.V.Sindhu in Amaravati, but the extent of Ac.0.20 Cts sanctioned comes to 968 Sq Yds only. In view of the orders of the Government in Youth Advancement Tourism & Culture (Sports/YS) Department and considering the representation of Kum. P.V. Sindhu, the Commissioner, APCRDA has requested the Government to issue necessary amendment to G.O.Ms.No.281, Dt.21.07.2017 & G.O.Ms.No.369, Dt.18.10.2017 issued by MA&UD(CRDA-2) Department as regards the extent sanctioned as 1000 Sq Yds. instead of Ac. 0.20 Cts.

4. After careful examination in the matter, Government hereby issue the amendment to the G.O 2nd and 3rd read above as follows:

Amendment

The extent of Residential Plot sanctioned to Kum. P.V. Sindhu, Silver Medalist of Rio Olympics, 2016 indicated in para 3 at serial No.17 shall be read as 1000 sq.yds.
