**NOTIFICATION**

In exercise of the powers conferred by sub-section (2) of section 17 of the Andhra Pradesh Capital Region Development Authority Act, 2014 (Andhra Pradesh Act No. 11 of 2014) the Government, hereby makes the following variation to the General

P.T.O

Town Planning of Nuzividu Municipality, as per section 41 of the said Act, which has been previously published in Extraordinary issue of Andhra Pradesh Gazette No. 352, Part-I, dated.15.09.2014.

### **VARIATION**

The site under reference measuring to an extent of 8781.99 sq. Mts in Sy.No..800/1A,1B,1C of Nuzividu Municipality, Krishna district. The boundaries of which are given in the schedule below and which was earmarked for Tank Use & 40'-0" road in the General Town Planning of Nuzividu Municipality which was sanctioned in G.O.Ms.No.477 M.A., Dt.19.09.2000 is now designated for Residential Use as the proposed site is surrounded by residential developments, subject to providing buffer on Northern side abutting the tank as per G.O.Ms. No.168, MA & UD, Dated: 07.04.2012 and 40'-0" road deletion is not accepted and the said road to be realigned slightly towards the applicant site, so as to avoid the alignment on the existing residential plots of LP No.156/90 as shown in Modification to General Town Planning Scheme vide M.G.T.P.No.02/2014/NZD which is available in the office of the Capital Region Development Authority, Vijayawada, subject to the following conditions:

1. that the title and Urban Land Ceiling / Agricultural land ceiling aspect shall be scrupulously examined by the concerned authorities i.e., Urban Development Authorities / Municipal Corporations / Municipalities before issue of building permission / development permission, and it must be ensured that the best financial interests of the Government are preserved.
2. that the above change of land use is subject to the condition that may be applicable under the Urban Land Ceiling, Act, 1976 and A.P. Agriculture Ceiling Act.
3. the owners / applicants are solely responsible for any misrepresentation with regard to ownership / title, Urban Land Ceiling Clearances etc. The owners / applicants shall be responsible for any damage claimed by any one on account of change of land use proposed.
4. the change of land use shall not be used as the proof of any title of the land.
5. the change of land use shall not be used as the sole reason for obtaining exemption from the provisions of Urban Land Ceiling Act, 1976.
6. The applicant has to get approvals from the Competent Authority.
7. The applicant has to provide buffer on Northern side abutting the tank as per G.O.Ms. No.168, MA & UD, Dt.07.04.2012.
8. any other conditions as may be imposed by Vice-Chairman, Vijayawada, Guntur, Tenali, Mangalagiri Urban Development Authority, Vijayawada.
