ORDER:

In the reference 1st read above, the MC, AMRDA has requested to issue BRO and Administrative Sanction and release total Budget Estimates 2021-22 for an amount of Rs.195,00,00,000/- (Rupees One hundred and ninety five crores only) under the Head of Account 4217- Capital Outlay on Urban Development – 01 State Capital Development - 050 Lands- G.H.11 State Development Schemes - S.H (05) Land Pooling for New State Capital -530 Major Works - 532 Lands, in relaxation of Treasury Control & Quarterly Regulations so as to enable the AMRDA for implementation of the scheme of Payment of Annuity to the farmers, which is lumpsum amount being released at a time in a year.

2. After careful examination of the proposal, Government hereby accord administrative sanction and release an amount of Rs. 195,00,00,000/- (Rupees one hundred and ninety five crores only) under the Head of Account 4217- Capital Outlay on Urban Development – 01 State Capital Development - 050 Lands- G.H.11 State Development Schemes - S.H (05) Land Pooling for New State Capital -530 Major Works - 532 Lands in relaxation of Treasury Control & Quarterly Regulations in view of the requirement for implementation of the scheme of Payment of Annuity to the farmers.

The Assistant secretary to Government (DDO), Municipal Administration & Urban Development Department, Andhra Pradesh, Velagapudi shall draw the amount sanctioned at para (2) above and credit the amount to the P.D A/c of APCRDA (Major Head:8443 -Civil Deposits -00 - M.H.106 Personal Deposits -02- Grants in aid -SH 04 Urban Development Agencies-002 APCRDA-001 Grants-inAid Deposits (Commissioner of APCRDA).

4. The Metropolitan Commissioner, AMRDA shall take necessary action in the matter accordingly
