ORDER:

In the G.O 1st read above, orders were issued allotting land to an extent of Ac 152.93 cents to Fifteen (15) Organizations of Government of India Departments/Public Sectors undertakings/Corporations, Government of Andhra Pradesh Departments/Public Sector undertakings/Corporations, Private Organizations and individual in Capital Region Development Authority Region including allotment of land to "Xavier School of Management" to an extent of Ac.50.00.

2. In the reference 2nd read above, the Commissioner APCRDA, Vijayawada has informed that the present Father of Andhra Loyola College, which is an Institution working under XLRI (Xavier Labour Relations Institute) Management, who is local representative on behalf of XLRI (Xavier Labour Relations Institute) has requested that the land required in Amaravati is to establish XLRI (Xavier Labour Relations Institute) Campus, but the GO issued in favour of Xavier School of Management and finally requested for rectification of the same. The Commissioner, APCRDA has further informed that the request of Father of Andhra Loyola College Vijayawada was examined with reference to the documents submitted by XLRI (Xavier Labour Relations Institute) and recommended to consider the request of the XLRI (Xavier Labour Relations Institute) and issue suitable amendment to G.O.Ms No. 368 Dt: 18.10.2017 for changing the nomenclature of allottee as XLRI (Xavier Labor Relations Institute) instead of Xavier School of Management.

2. After careful examination in the matter, Government hereby issue the amendment to the G.O. 1st read above, as follows:-
