ORDER:

In the reference 1st read above, orders have been issued constituting Group of Ministers (GoM) to examine the issue of allocation of land to various Institutions, in the Capital City Region.

2. In the reference 2nd read above among others, orders have been issued allotting land to an extent of 5.00 acres to Kendriya Vidyalaya-1 at Thullur and to an extent of 5.00 acres to Kendriya Vidyalaya-2 at Nelapadu for nominal lease @ Rs.1.00 per Sq. Mt. per annum for a period of 60 years.

3. Subsequently, the Deputy Commissioner, Kendriya Vidyalaya Sangathan, Secunderabad has requested the Commissioner, APCRDA for allotment of additional land for an extent of 3.0 acres in one of the two KV schools in Amaravati to develop additional sporting facilities and also requested to revise the nominal rent from Rs.1.00 per Sq. mtr. Per annum to Rs.1.00/- for entire extent of each of the two schools.

4. The Group of Ministers(GoM) in its 9th meeting held on 24.10.2018, have discussed the issue and recommended for allotment of additional land of 3.0 acres to Kendriya Vidyalaya School located at Thulluru making the total extent 8.0 acres. GoM also recommends to fix the nominal rent amount as Rs.1.00/- for entire extent of land allotted to each of the KV Schools in Amaravati.

5. In partial modification of the orders issued in G.O.Ms.No.281, MA&UD(CRDA.2) Department, dt.21.07.2017, Government, after careful examination hereby revise the nominal rent from Rs.1.00 per Sq. mtr. Per annum to Rs.1.00/- for entire extent of land allotted to KV Schools in Amaravati.

6. The Commissioner, Andhra Pradesh Capital Region Development Authority, Vijayawada, shall scrupulously follow all other relevant rules and regulations while allocating the land and entering Agreement and take necessary action accordingly.
