**ORDER:**

Under section 52 of the Andhra Pradesh Capital Region Development Authority (CRDA) Act, 2014, Land Pooling Scheme Rules were notified vide G.O.Ms.No.1, Municipal Administration and Urban Development Department, dt:01-01-2015. The land owners in the villages notified in Capital City Area, vide G.O.Ms.No.254, dt:30-12-2014, have given their consent for joining the Land Pooling Scheme and Land Pooling Scheme was completed on 28-2-2015. The process of entering into development agreement under rule 8 (8) is to be taken up immediately. While the final notification of Land Pooling Scheme, under section 57 (2) of the Act, will vest the land with the Capital Region Development Authority, it is necessary in certain circumstances to register these instruments of transactions in Form 9.14 before the final notification, so as to facilitate immediate development activity in the Capital City Area. The Government have considered the need to quicken the pace of work in Capital Development and decided to exempt Registration Fee on such instruments.

2. Accordingly, the following notification will be published in an Extra-ordinary issue of the Andhra Pradesh Gazette, dated:05.01.2016.
