ORDER:-

In the letter 2nd read above, the Commissioner, APCRDA has stated that the provision required for payment of Pensions to the Landless families in the Capital City Area, NTR Vaidhya Seva, Free Education and NTR canteens for the families of Capital City Area guaranteed in the APCRDA Act under the Head of Account "2217- Urban Development – 01 State Capital Development- 800 Other Expenditure - GH 11 State Development Schemes – SH (08) Capital Region Social Security Fund –310 Grants –in-Aid -312 Other Grants –in- Aid", has been projected at Rs.84,24,00,000/- to be fixed as Budget Estimates 2019-20.

2. The Commissioner, APCRDA has also stated that Government in Finance Department (in the ref.1st read above) have issued orders informing that an Advance Grant (Vote on Account) for the part of the year (roughly equal to the Expenditure likely to be incurred during the 1st four months of the F.Y 2019-20) has been obtained from the Legislature for incurring expenditure.

3. The Commissioner, APCRDA has further stated that in view of the requirement for implementation of the scheme of payment of pensions to landless families at the revised rates, the Commissioner, APCRDA has requested the Government to sanction and release an amount of Rs.21,05,79,000/- (Rupees Twenty one crores Five lakhs seventy nine thousand only) under the Head of Account "2217-Urban Development - 01 State Capital Development-800 Other Expenditure - GH 11 State Development Schemes – SH (08) Capital Region Social Security Fund –310 Grants –in-Aid -312 Other Grants –in- Aid", for utilization during the 1st quarter of the Financial year for implementing the scheme of payment of pensions to the landless families.

4. The Commissioner, APCRDA has stated that as the APCRDA is an autonomous body with no subordinate controlling officers, an amount of Rs.21,05,79,000/- out of the total projected provision of Rs.84,24,00,000/- may be drawn and Credited to the P.D A/c of APCRDA(Major Head:8448 – Deposits of Local Funds – 00 - M.H.120 Other Funds – 00- SH 19-000-000 Commissioner of APCRDA) to enable to incur expenditure for implementation of the scheme.

5. The Commissioner, APCRDA has also requested the Government to authorize the Assistant Secretary to the Government, MA&UD Department, Govt. of A.P., Amaravati (DDO) to draw and credit the amount to the P.D.A/c of APCRDA, after obtaining budget authorization from the Director of Treasuries and Accounts, A.P., Ibrahimpatnam, Vijayawada..

6. After careful examination of the proposal, Government hereby sanction and release an amount of Rs.21,05,79,000/- (Rupees Twenty one crores Five lakhs seventy nine thousand only) under the Head of Account "2217-Urban Development - 01 State Capital Development- 800 Other Expenditure - GH 11 State Development Schemes - SH (08) Capital Region Social Security Fund - 310 Grants -in-Aid -312 Other Grants -in-Aid", towards payment of Pensions to landless families in Capital City Area for utilization during the 1st quarter of the Financial year 2019-20.

7. The Assistant Secretary to Government (Drawing Officer), Municipal Administration & Urban Development Department, Andhra Pradesh, Velagapudi, shall draw the amount sanctioned in para (06)above for credit to the P.D. Account of APCRDA (Major Head: 8448 Deposit of Local Funds - 00 - M.H.120 Other Funds - 00 - SH 19- 000 - 000 Commissioner of APCRDA).

08. The Director of Treasuries and Accounts, Andhra Pradesh, Ibrahimpatnam is requested to issue authorization for the amount sanctioned in para (3) above.
