#### **ORDER:-**

In the letter 1<sup>st</sup> read above, the Commissioner, APCRDA Vijayawada, has sent proposals for issue of Comprehensive Budget Release Order and apportionment of approved Budget.

2. In the G.O 2<sup>nd</sup> read above, Government in Finance (FMU-I-I, EF, MA)Department, among others, have issued Comprehensive Budget Release Order for an amount of Rs. 70,50,00,000/- from the BE Provision 2017-18 and apportioned the approved Budget towards meeting the expenditure through Capital Region Social Security Fund.

3. In consideration of the orders issued in the G.O 2<sup>nd</sup> read above, Government, after careful examination of the matter, and hereby accord administrative sanction for an amount of Rs. 70,50,00,000/- (Rupees seventy crores and fifty lakhs only) under the **Head of Account: "2217-Urban Development, 01-State Capital Development, 800-Other Expenditure, G.H.11-State Development Schemes, SH(08)- Capital Region Social Security Fund, 310- Grants-In-Aid, 312-Other Grants-In-Aid (Voted)" from the BE Provision 2017-18** towards meeting the expenditure through Capital Region Social Security Fund.

4. The Commissioner, APCRDA, Vijayawada, has informed in his letter 3<sup>rd</sup> read above, that the expenditure under capital region social security fund consists of payments towards (1) Pensions to land less families (2) NTR Vaidya seva (3) Free education & (4) NTR Canteens in the Capital City Area. he has informed that the estimated expenditure towards pensions to landless families (22,500) comes to Rs.67,50,00000/- for the financial year 2017-18. Pending proposals to the remaining schemes, the Commissioner, APCRDA, Vijayawada, has requested to issue administrative sanction for an amount of Rs 70,50,00,000 and release of an amount of Rs.33,75,00,000/- under the above head of account for utilization during the 1st and 2nd quarters for payment of pensions to the landless families.

5. In view of the above, Government hereby release an amount of 33,75,00,000/- (Rupees Thirty Three Crore Seventy Five Lakhs Only ) to CRDA towards 1st and 2nd quarters for the Financial Year 2017-18 under the Head of Account "**2217- Urban Development, 01-State Capital Development, 800-Other Expenditure, G.H.11-State Development Schemes, SH(08)- Capital Region Social Security Fund, 310- Grants-In-Aid, 312-Other Grants-In-Aid (Voted)**" .

6. The Assistant Secretary to Government (Drawing Officer), Municipal Administration & Urban Development Department, Andhra Pradesh, Velagapudi, shall draw the amount sanctioned in para (3) above and credited to the PD A/C of APCRDA.(Major Head:8448 Deposit of Local Funds - 00 - MH.120 other funds - 00 - SH 19 Commissioner of APCRDA - 000 - 000 ).

7. The Director of Treasuries and Accounts, Andhra Pradesh, Vijayawada, is requested to issue authorization for the amount sanctioned in para (3) above.
