ORDER:

In the reference 3rd read above, Government have issued orders by sanctioning and releasing an amount of Rs.30,00,00,000/- (Rupees Thirty crores only) under the Head of Account "2217-Urban Development - 01 State Capital Development - 800 Other Expenditure - GH11 State Development Schemes SH (08) Capital Region Social Security Fund - 310 Grants-in-Aid - 312 Other Grants-in-Aid", towards payment of pensions to the land less families in the Capital City Area for utilization during the 1st quarter of the Financial year 2021-22 as per Advance Grant (Vote on Account) for the part of the year (approximately equal to the expenditure requirements of the first three months of the financial year 2021-22), issued by the Finance Department, vide G.O.Ms.No.21, Finance(Budget-I) Department, dt:30.03.2021.

2. In the reference 4th read above, Government in Finance Department has issued Comprehensive Budget Release Order (CBRO) for an amount of Rs.120,00,00,000/- under the Head of Account "2217-Urban Development -01 State Capital Development - 800 Other Expenditure - GH 11 State Development Schemes SH (08) Capital Region Social Security Fund - 310 Grants-in-Aid - 312 Other Grants-in-Aid" and instructed to ensure that the distribution of budget among the SCO-DDOs under the control of the Department and the HoD Office, duly allocating the amount for the Four Quarters. Government have apportioned the provision among four quarters @ of Rs.30,00,00,000/- (Rupees Thirty crores) for the each quarter.

3. In the reference 5th read above the MC, AMRDA has requested to sanction and release an amount of Rs.30,00,00,000/- (Rupees Thirty crores only) under the Head of Account "2217 - Urban Development - 01 State Capital Development - 800 Other Expenditure - GH 11 State Development Schemes - SH (08) Capital Region Social Security Fund - 310 Grants-in-Aid - 312 Other Grants-in-Aid", towards payment of pensions to the land less families in the Capital City Area during the 2nd quarter of the Financial year 2021-22 for implementation of the scheme of payment of pensions to the landless families.

4. The Metropolitan Commissioner, AMRDA, Vijayawada, has also stated that as the APCRDA is an autonomous body with no subordinate controlling officers, an amount of Rs.30,00,00,000/- (Rupees Thirty crores) out of total Budget estimates of Rs.120,00,00,000/- may be drawn and Credited to the P.D A/c of APCRDA (Major Head:8443 - Civil Deposits - 00 - M.H.106 Personal Deposits - 02 - Grants-in-aid - SH 04 Urban Development Agencies - 002 APCRDA - 001 Grants-in-Aid Deposits (Commissioner APCRDA) to enable to incur expenditure for implementation of the scheme.

5. After careful examination, Government hereby issued administrative sanction to release an amount of Rs.30,00,00,000 /- (Rupees Thirty crores) under the Head of Account mentioned at para (3) above, for utilization during the 2nd quarter of the Financial year for implementing the scheme of payment of pensions to the landless families in the Capital City Area for the F.Y 2021-22.

6. The Assistant secretary to Government (DDO), Municipal Administration & Urban Development Department, Andhra Pradesh, Velagapudi shall draw the amount sanctioned in para (5) above and credit to the P.D. Account of APCRDA (Major Head:8443 - Civil Deposits - 00 - M.H.106 Personal Deposits - 02-Grants-in-aid - SH 04 Urban Development Agencies - 002 APCRDA - 001 Grants-in-Aid Deposits) to enable to incur expenditure for implementation of the scheme.

7. The Metropolitan Commissioner, AMRDA shall take necessary action in the matter accordingly.
