ORDER:-

In the G.O 1st read above Government have accorded administrative sanction for implementation of the scheme of payment of pension of Rs.2,500/- per month, per family for a period of 10 years to the eligible landless families as identified with reference to the Rule 5(3) of the A.P Capital City Land Pooling Scheme (Formulation and Implementation) Rules, 2015 in Capital City Area and rules in force.

2. In the G.O 2nd read above, Government, have issued operational guidelines for implementation of the "Landless families Pension Scheme" in Andhra Pradesh Capital City Area, Amaravati.

3. In the G.O 3rd read above, Government in Finance (FMU-I-I, EF, MA)Department, among others, have issued Comprehensive Budget Release Order for an amount of Rs. 70,50,00,000/- under Plan from the BE Provision 2016-17 towards meeting the expenditure for payment of pension to landless families in Capital Region through Capital Region Social Security Fund.

4. In the G.O. 5th read above, administrative sanction orders were issued for the entire amount of Rs.70,50,00,000/- and released an amount of Rs.17,62,50,000 for 1st quarter of FY 2016-17. The sanctioned amount has been drawn and credited to the P.D.A/c of APCRDA (i.e., Major Head:8448- Deposits of Local Funds Minor Head:120 – Other Funds S.H.19- Commissioner, APCRDA, Vijayawada).

5. In the G.O.6th read above, the Finance Department have issued orders that the funds allocated under the HoA: "4217-Capital Outlay and urban Development -01-State Capital Development-050- Land G.H.11-State Development Plan -S.H-(08)-Capital Region Social Security Fund -310- Grants-In-Aid 312-Other Grants-In-Aid" were resumed as per the objections raised by the Accountant General.

6. In the G.O.7th read above, the Finance Department have issued Budget Release Order for an amount of Rs.70,50,00,000/- as additional funds in relaxation of Treasury control and quarterly regulation orders pending submission of supplementary estimates during the Financial Year 2016-17 towards meeting the expenditure for payment of pension to landless families in APCRDA area under the Head of Account: "2217- Urban Development, 01-State Capital Development, 800-Other Expenditure, G.H.11-State Development Plan, SH(08)- Capital Region Social Security Fund, 310- Grants-In-Aid, 312-Other Grants-In-Aid (Voted)" and advised the MA&UD Department to account for

the 1st quarter amount of Rs 17.6250 cr already drawn in the old Head of Account:4217-01-050-11-(08)-310/312, duly remitting the same into Govt Account through challan.

7. In supersession of orders issued in G.O.5th read above, Government, after careful examination of the matter, hereby accord revised administrative sanction for an amount of Rs. 70,50,00,000/- (Rupees seventy crores and fifty lakhs only) under the Head of Account: "2217- Urban Development, 01-State Capital Development, 800-Other Expenditure, G.H.11-State Development Plan, SH(08)- Capital Region Social Security Fund, 310- Grants-In-Aid, 312-Other Grants-In-Aid (Voted)" from the BE Provision 2016-17 towards meeting the expenditure for payment of pension to landless families in Capital Region through Capital Region Social Security Fund.

8. Government, also hereby release an amount of Rs.35,25,00,000/- (Rupees Thirty five crores and twenty five lakhs) to CRDA towards 1st and 2nd quarters for the FY 2016-17 under the Head of Account: "2217- Urban Development, 01-State Capital Development, 800-Other Expenditure, G.H.11-State Development Plan, SH(08)- Capital Region Social Security Fund, 310- Grants-In-Aid, 312-Other Grants-In-Aid (Voted)".

9. The Assistant Secretary to Government (Drawing Officer), Municipal Administration & Urban Development Department, Andhra Pradesh, Hyderabad shall draw the amount sanctioned in para (8) above and credited to the PD A/C of APCRDA.

10. The Commissioner, APCRDA shall account for the 1st quarter amount of Rs 17.6250 cr already drawn in the old Head of Account:4217-01-050-11-(08)-310/312, duly remitting the same into Government Account where the amount was drawn i.e., Head of Account:4217-01-050-11-(08)-310/312, through challan and furnish compliance to the Government under copy marked to the Finance (FMU-I-I,EF,MA) Department.

11. The Director of Treasuries and Accounts, Andhra Pradesh, Vijayawada is requested to issue authorization for the amount sanctioned in para (8) above.

12. The Commissioner, APCRDA shall furnish the proposal for Supplementary Grants at appropriate time during the Financial Year 2016-2017.
