**ORDER:**

In the reference 4<sup>th</sup> read above, Government have issued orders by sanctioning and releasing an amount of Rs.16,25,00,000/- (Rupees Sixteen crores twenty five lakhs only) under the Head of Account "2217-Urban Development - 01 State Capital Development - 800 Other Expenditure - GH11 State Development Schemes SH (08) Capital Region Social Security Fund 310 Grants-in-Aid -312 Other Grants-in- Aid", towards payment of pensions to the land less families in the Capital City Area for utilisation during the 1<sup>st</sup> quarter of the Financial year 2020-21 as per Advance Grant (Vote on Account) for the part of the year (approximately equal to the expenditure requirements of the first three months of the financial year 2020-21) as issued by the Finance Department, vide G.O.Ms.No.28, Finance(Budget-I) Department, dt:06.04.2020.

2. In the reference 5<sup>th</sup> read above, Government in Finance Department has issued Comprehensive Budget Release Order (CBRO) for an amount of Rs.65,00,00,000/- and requested the MA&UD Department to issue Budget Distribution Order apportioning the Budget among the SCO-DDOs of the Department and the HoD Office, duly allocating the amount for the Four Quarters. In the said G.O an amount of Rs.65,00,00,000/- (Rupees Sixty five crores only) pertaining to APCRDA for the Financial Year 2020-21 has been included towards meeting the expenditure for four schemes i.e. payment of pensions to landless families in the Capital City Area, Vaidhya Seva, Free Education and canteens for the families of Capital City Area guaranteed in the APCRDA Act under the Head of Account "2217-Urban Development -01 State Capital Development -800 Other Expenditure – GH11 State Development Schemes SH (08) Capital Region Social Security Fund 310 Grants- in-Aid - 312 Other Grants-in-Aid". Government have apportioned the provision among four quarters @ of Rs.16,25,00,000/- for the each quarter (i.e. 1<sup>st</sup> quarter Rs.16,25,00,000/-, 2<sup>nd</sup> quarter Rs.16,25,00,000/-, 3<sup>rd</sup> quarter Rs.16,25,00,000/- and Rs.16,25,00,000/- for the 4<sup>th</sup> quarter).

3. In the reference 7<sup>th</sup> read above, Government have issued administrative sanction to release an amount of Rs.16,25,00,000/- (Rupees sixteen crores twenty Five lakhs only) under the Head of Account "2217-Urban Development - 01 State Capital Development - 800 Other Expenditure - GH11 State Development Schemes SH (08) Capital Region Social Security Fund 310 Grants in-Aid -312 Other Grants-in- Aid", for utilization during the 2<sup>nd</sup> quarter of the Financial year for implementing the scheme of payment of pensions to the landless families.

4. In the reference 9<sup>th</sup> read above, Government have issued administrative sanction to release an amount of Rs.16,25,00,000/- (Rupees sixteen crores twenty Five lakhs only) under the Head of Account "2217-Urban Development - 01 State Capital Development - 800 Other Expenditure - GH11 State Development Schemes SH (08) Capital Region Social Security Fund 310 Grants in-Aid -312 Other Grants-in- Aid", for utilization during the 3<sup>rd</sup> quarter of the Financial year for implementing the scheme of payment of pensions to the landless families.

5. In the reference 10<sup>th</sup> read above, the Metropolitan Commissioner, AMRDA(erstwhile APCRDA) has requested the Government to sanction/release the 4<sup>th</sup> quarter amount of Rs.16.25 Crs. (Rupees Sixteen crores twenty five lakhs only) under the Head of Account Head of Account "2217-Urban Development - 01 State Capital Development - 800 Other Expenditure- GH 11 State Development Schemes - SH (08) Capital Region Social Security Fund - 310 Grant in Aid - 312 Other Grants - in - Aid", for implementation of the scheme of payment of pensions to the landless families.

6. After careful examination, Government hereby issued administrative sanction to release an amount of Rs.16,25,00,000/- (Rupees sixteen crores twenty Five lakhs only) under the Head of Account mentioned at para (5) above, for utilization during the 4<sup>th</sup> quarter of the Financial year 2020-21, for implementation of the scheme of payment of pensions to the landless families.

7. The Assistant Secretary to Government (Drawing Officer), Municipal Administration & Urban Development Department, Andhra Pradesh, Velagapudi, shall draw the amount sanctioned in para (6) above for credit to the P.D. Account of APCRDA (now AMRDA) (Major Head:8443-Civil Deposits - 00 - M.H 106 Personal Deposits - 02- Grants - in -Aid - SH 04 - Urban Development Agencies - 002 - APCRDA - 001 Grants - in -Aid Deposits) to enable to incur expenditure for implementation of the scheme continuously.

8. The Metropolitan Commissioner, AMRDA, Vijayawada, shall take further action accordingly.
