**ORDER:-**

In the G.O 1<sup>st</sup> read above, Government in Finance (FMU-I-I,EF&MA) Department, among others, have issued Comprehensive Budget Release Order for an amount of Rs.70,50,00,000/- from the BE Provision 2017-18 and apportioned the approved Budget towards meeting the expenditure through Capital Region Social Security Fund.

2. In the reference 2<sup>nd</sup> read above, an amount of Rs.33,75,00,000/- was released for utilization during the 1<sup>st</sup> and 2<sup>nd</sup> quarters for payment of pensions to the landless families.

3. In the reference 3<sup>rd</sup> read above, the Commissioner, Andhra Pradesh Capital Region Development Authority has requested the Government to sanction and release an amount of Rs.29,81,00,000/-(Rupees Twenty Nine crores and Eighty One lakhs) to the Scheme of payment of Pensions to Landless Families in the Capital City Area towards 3<sup>rd</sup> & 4<sup>th</sup> Quarters of the Financial Year 2017-18, under the following Head of Account, and the amount may be credited to the P.D.A/c of APCRDA (8448- 00- 120- 00-(19)- 000- 000) to ensure prompt payment. The Commissioner, APCRDA, Vijayawada, has informed that APCRDA is an Autonomous Body with no subordinate controlling officers the amount of Rs.29,81,00,000/- (Rupees Twenty Nine crores Eighty One lakhs only) shall have to be drawn and credited to the P.D A/c of APCRDA **(Major Head:8448 – Deposits of Local Funds –00 - M.H.120 Other Funds –00- SH 19-000-000 Commissioner of APCRDA )** to enable to incur expenditure for implementation of the scheme.

4. After careful examination of the proposal, Government hereby release an amount of Rs.29,81,00,000/- (Rupees Twenty Nine Crores Eighty One Lakhs only)

as the amount is actually required based on assessment, under the **Head of Account: "2217- Urban Development, 01-State Capital Development, 800-Other Expenditure, G.H.11-State Development Schemes, SH(08)- Capital Region Social Security Fund, 310- Grants-In-Aid, 312-Other Grants-In-Aid (Voted)" from the BE Provision 2017-18,** towards payment of pensions to landless families in capital city area in relaxation to quarterly regulations for utilisation during the 3<sup>rd</sup> & 4<sup>th</sup> quarters of the financial year 2017-18.

5. The Assistant Secretary to Government (Drawing Officer), Municipal Administration & Urban Development Department, Andhra Pradesh, Velagapudi, shall draw the amount sanctioned in para (4) above and credited to the PD A/C of APCRDA. (**Major Head:8448 Deposit of Local Funds – 00 – M.H.120 other funds - 00 – SH 19 Commissioner of APCRDA – 000 - 000** ).

6. The Director of Treasuries and Accounts, Andhra Pradesh, Vijayawada, is requested to issue authorization for the an amount of Rs.29,81,00,000/- (Rupees Twenty Nine Crores Eighty One Lakhs only) sanctioned in para (4) above.
